# **INTRODUCTION**

The **Qualified Mediator (Family)** designation recognizes member applicants who have completed sufficient training in mediation and related dispute resolution to be qualified to practice as entry-level mediators in separation and divorce matters while continuing to learn with a goal to becoming a **Chartered Mediator (Family)**.

The designation assists the mediator by providing a nationally recognized credential to show that the mediator has met nationally and regionally set standards for training and/or experience as a family mediator.

The credential will assist the public to select a mediator who has been reviewed to determine that the mediator is qualified and held to an ongoing standard.

#### CRITERIA

To achieve a Q.Med(Fam), a mediator must fulfill all of the following requirements:

# I. EDUCATION

A minimum of 140 hours of ADRIC-Accredited training comprised of:

- a) Minimum 40 hours of basic mediation training and
- b) Minimum 100 hours of specialized mediation and related training including a minimum of 80 hours specialized Family Mediation training.

#### a) Basic Mediation Training (Required):

Minimum 40 hours (one or two ADRIC-Accredited courses spanning five days) covering all of the following areas:

- Interest-based Mediation Process and Skills
- Conflict Resolution
- Negotiation
- Communication Skills

#### b) Specialized Mediation and Related Training

Minimum of an additional 100 hours of ADRIC-Accredited specialized training in dispute resolution or related field, which must include a minimum of 80 hours specialized Family Mediation training which must include:

- Minimum 21 hours dynamics in separation and divorce including:
  - o parenting plans
  - o family dynamics
  - o emotional impact of separation & divorce
  - impact on children
  - o managing power
  - o case development

- Minimum 28 hours of legal and financial issues in separation and divorce (practicing family law lawyers exempt) including:

  - o understanding the legislation, regulations and guidelines governing separation and divorce
- Minimum 7 hours drafting summaries and memorandum of understanding (including both parenting plans and financial issues)
- Minimum 14 hours family violence and Intimate Partner Violence training that encompasses understanding risk factors in separation and divorce and safety screening
- Minimum 7 hours ethical issues in mediation

# II. EXPERIENCE

#### a) Administrative Experience

- Demonstrated ability to handle the administrative aspects of a separation/ divorce mediation from beginning to end by describing your typical process from intake of clients to follow-up after the mediation. Include
  - i. Sample of your Agreement to Mediate
  - ii. Any other paperwork you use with clients.
  - iii. Copy of a redacted separation/ divorce mediated agreement to show knowledge of the process (or provide a sample based on your supervised practice mediation).

#### b) Practical Experience

• Two years of experience working with families in a related context

AND

• Two family co-mediations (paid or unpaid) where the applicant has clearly been the lead mediator

For the co-mediations, an attestation must be provided by a C.Med(Fam) or in their absence a C.Med with experience in family mediation.

#### c) Skills Assessment

One practice family mediation supervised by an Affiliate-Approved Supervisor/Assessor

# III. MEMBERSHIP

A Qualified Mediator must at all times be a FULL member of good standing of ADRIC via one of its Regional Affiliates.

# IV. CONTINUING EDUCATION AND ENGAGEMENT (CEE)

Qualified Mediators (Family) are required to acquire a minimum of 20 points annually of which 6 points must relate to Separation & Divorce dispute resolution. CEE reports are to be submitted by December 31<sup>st</sup> each year. Details and forms may be found at: <u>http://adric.ca/resources/professional-designations/continuing-education-engagement/</u>

#### V. INSURANCE

All self-employed Q.Med(Fam) are required to sign and submit the Declaration of Insurance form, indicating that they maintain Errors and Omissions Insurance with a limit of at least \$1 million aggregate or check the appropriate box for an exemption of the requirement. (Those who are employed by others should have insurance coverage under their employer.)

## VI. PLEDGE

The applicant must pledge to comply with ADRIC's Code of Ethics and Code of Conduct.

## VII. ANNUAL FEES

Each Regional Affiliate sets its designation application fee. Annual Designation Maintenance/Renewal fees are also required to ADRIC to maintain the designation in addition to membership dues. # **APPLICATION FORMS**

To apply for Qualified Mediator (Family) status, complete the Application Form provided by your Regional Affiliate and return it to your Regional Affiliate along with their required application fee.
